- 1. If chosen as a finalist, you will receive the \$250 finalist award only if you perform in the finals on 6/4/16, scheduled as follows: strings 9:00 A.M.-12:00 P.M., winds 10:15 A.M.-1:35 P.M., piano 12:30-3:25 P.M., voice 1:35-4:40 P.M.
- 2. If chosen as a winner, you will attend a meeting at 6:30 P.M. and participate in the Winners Concert 7:00-9:00 P.M. on 6/4/16.
- 3. If chosen as a winner, you will participate in the tour 9/11/16-9/16/16, as described in the information sheet, including two to four hours of playing/singing a day. The \$3000 award will be presented upon completion of the tour.
- 4. If participating in the tour, you will be willing to share a room (separate beds) with one roommate.
- 5. If you are a smoker, you will refrain from smoking on the tour.
- 6. You will forfeit the title of winner, the \$3000 award, and future eligibility for this competition if you do not participate in the tour.
- 7. If you are an alternate winner performing because a winner is unable to do the tour, you will gain the title of winner, receive the \$3000 award, and will no longer be eligible for this competition.
- 8. Transportation to and from Seattle for yourself and your instrument, for the competition and the tour is your responsibility. Transportation, lodging, meals, and collaborative pianist will be provided on the tour by LMC.
- 9. Pianists will play the piano available at the competition and each stop of the tour. LMC can provide no other type of instrument or money to rent an instrument, either for the competition or for the tour.
- 10. If your instrument is harp or double bass LMC will provide the funds for a second vehicle on tour if needed for transportation. LMC cannot guarantee a second driver, so it will be your responsibility to help with driving on the tour. If your vehicle is used, LMC will pay for gas and ferry fees during the tour.
