### **Award Package**

#### **Finalists**

- Finalist Award of \$250 for each musician, including each member of ensembles
- Finalists receive professional photography and video of their competition performance

#### Two Solo Winners and One Ensemble Winner

- \$3,500 for each solo winner and each member of the winning ensemble
- Winners receive professional photography and video of the Winners' Concert
- Tours to be held in Washington State September 8-16, 2022, including outreach performances to public schools K-12 and public concerts

 Live performance on Classical KING-FM 98.1, the Pacific Northwest's premier Classical radio station

The FWC Winners' cash prizes will be awarded at the successful completion of the FWC Winners' September 2022 tour. Successful completion of the tour is a material component of the competition and is a required condition of the award and payment of the prize package as well as the right to claim the title of "Frances Walton Competition Winner."

#### Eligibility

- Solo applicants 20 to 35 years of age (birthdate on or between June 4, 1987, and June 4, 2002)
- All applicants must be a legal resident of, or music student holding a valid U.S. visa residing in the United States, the District of Columbia, or one of the U.S. Territories.
- All applicants must have either a U.S. Social Security number or IRS tax ID number and must provide a valid IRS Form W-9, in order to receive cash awards.
- It is highly likely that FWC Winners will be required to show proof of vaccination against COVID-19 in order to perform in public schools in the State of Washington on the FWC Tours.
- Solo winners of the FWC may not re-enter as a solo applicant.
- Solo winners may enter as an ensemble member.

## **String Applications**

- Guitar: unaccompanied, solo works only
- All other stringed instruments: concerto movements are accepted only if accompanied by piano reduction
- Single movements from a larger work are acceptable
- No electric instruments or electronic enhancements
- No compositions that include prepared piano, e.g. as in works by John Cage https://en.wikipedia.org/wiki/Prepared piano
- Unaccompanied works are accepted, if originally written as such
- Recordings must be submitted in four separate tracks as follows:

Track one: From Baroque or Classical periods

Track two: From Romantic period

Track three: From the Twentieth Century to the present Track four: A piece of your choice from any period

- All recordings must be made after September 15, 2020.
- The first round of the FWC is anonymous. Please do not speak or enter your name on the recording upload.

It is the responsibility of all applicants, in particular harpists and marimbists, to read the FWC Finals Information <a href="here">here</a> and the FWC Tour Information <a href="here">here</a> BEFORE applying for the FWC to

understand the Finals, as well as the rigors of the Tours and repertoire choices that may need to be made should you win the FWC.

All FWC Winners will perform at the Winners Concert at the University Congregational United Church of Christ in Seattle, WA on Sunday, June 5, 2022, at 2:00 PM.
